If you wish to vote for a candidate seeking a nonpartisan office or on a public question, you must make another voting mark on the appropriate place on the ballot. To vote for a Write-In candidate, mark the box provided to the left of the words "Write-In" and write in the name of the candidate on the line provided. "A Write-In Vote Will Not Be Counted Unless The Vote Is For A DECLARED Write-In Candidate".

**PUBLIC QUESTION**

"Shall Article 10, Section 5 of the Constitution of the State of Indiana be amended to require the General Assembly to adopt balanced budgets for state government that do not exceed estimated revenues unless a supermajority of two-thirds of the members of the House of Representatives and two-thirds of the members of the Senate vote to suspend the requirement?"
