STRAIGHT PARTY

- (1) You are not required to vote a straight party ticket. If you do not wish to vote a straight party ticket, do not make a mark in this section, and proceed to voting the ballot by office.
- (2) To vote a straight Democratic, Republican or Libertarian ticket for all Democratic, Republican, or Libertarian candidates on this ballot, except for candidates described in (3) below, make a voting mark on or in this box and do not make any other marks on this ballot.
- (3) To vote for any candidate for an at-large office (Township Board), to which more than one (1) person may be elected, you must make another voting mark for each candidate you wish to vote for. Your straight

party vote will not count as a vote for any candidate for		
that office.		
(4) If you wish to vote for a candidate seeking a non-		
partisan office, you must make another voting mark on		
the appropriate place on this ballot.


